58.22 Chairman's Welcome

In the absence of Councillor Padmore, Councillor Blake chaired the meeting. After welcoming everyone, he then paid tribute to Her Majesty Queen Elizabeth II noting that we had all been deeply saddened to hear of her passing and wished to express heartfelt condolences, on behalf of Uffington Parish Council, to The King and the rest of the Royal Family at this sad time.

59.22 Apologies for Absence

Apologies were received from Councillors L Padmore and J Carter.

60.22 Disclosable Pecuniary Interests

- b) There were no applications for a dispensation regarding disclosable pecuniary interests.

61.22 Public Participation

62.22 To approve the minutes of the Parish Council Meeting held on 11 July 2022

63.22 Clerk's Report on matters arising from the minutes of the Parish Council Meeting of 11 July 2022.

 Advised E.ON to go ahead with the replacement street light. Work expected to be carried out in October.

- Reported highways issues to Shropshire Council. Grass triangle at the Upton Magna turn has since been cut along with Sundorne island.
- Contacted Opdenergy to discover the results of the questionnaire regarding the proposed solar farm. [Councillor Picton left the room].

Opdenergy had sent out over 500 questionnaires to residents of Uffington and the surrounding area. 38 completed questionnaires had been returned via freepost. The results were:

Opdenergy had not yet submitted a planning application to Shropshire Council, so no further discussion took place. If a planning application is submitted before the next scheduled meeting of the Parish Council in November, then an extraordinary meeting will be convened to consider. [Councillor Picton rejoined the meeting].

64.22 To receive report from Shropshire Councillor and/or Safer Neighbourhood Team (West Mercia Police)

Nobody from the SNT was able to attend.

Councillor Picton presented a brief report: Following the resignation of Boris Johnson, Shropshire Council had been a little "rudderless" as hadn't known what was going on policy-wise. Liz Truss was appointed Prime Minister and managed to announce one policy (energy cap) before Her Majesty The Queen had died and parliament was suspended. The Council is not relying on a bail out from the government and is working hard to balance the budget and sorting out the deficit for next year.

The Queen dying in Scotland brought into force Operation Unicorn and Operation London Bridge and both of these resulted in much organisation on the part of Shropshire Council.
