

**Uffington Parish Council  
Meeting  
Monday 11<sup>th</sup> November 2019**

**MINUTES**

1. **Chairman's Welcome** The chairman welcomed all to the meeting
2. **Declarations of Pecuniary Interest;** Councillor R Davies declared an interest in planning application 19/04727/PMBPA
3. **Present** Councillor L Padmore-Chairman, Councillor P Daimond-Vice-chairman, Councillor R Davies, Councillor E Strawbridge, Shropshire Councillor L Picton, L Pardoe clerk to the Council and one member of the public .Apologies were received from Councillor A Blake who was working. Apologies were also received from J Jordan from Sundorne Estates
4. **Public Session.** *Standing Orders were lifted to allow the public to speak* Mrs Ashton reported that there was still dog fouling occurring on the footpath. She also reported that the dog signs that had been on the signposts were no longer there. The clerk to request two new dog signs one outside the estate house and one outside Mrs Ashton's house from the dog warden.

Severn Trent have replied to the request for their operatives to clear the rubbish in their compound up they will ensure that this is done.  
The grass on and around the Sundorne Roundabout has now been cut back as promised by Steve Brown from Shropshire Council.
8. **To receive Reports from Shropshire Councillor L Picton.** Councillor Picton reported that she had reported some fly tipping by the A5. Shropshire Council were still in financial trouble with more cuts being needed next year.
9. **Traffic Calming proposals for the village;** The parish council have agreed to have some VAS installed by E-on and they are also looking to have an additional 4 street lights installed through the village. They are awaiting confirmation from Garry Johnson from E-on that Shropshire Council will allow this and also that there are no objections from the residents who may be affected by the new lights.
