MINUTES

1. **Chairman's Welcome;** The Chairman welcomed all to the meeting
2. **Present:** Councillor L Padmore- Chairman; Councillor H Booth- Vice-chairman; Councillor R Davies; L Pardoe clerk to the Council. L Picton candidate for Shropshire Council, Mrs. B Ashton .**Apologies** were received from Mathew Mead at Shropshire Council.
3. **Public session.** Mrs. Ashton told the meeting that the PP3 group had been tasked with surveying the Severn Way in the parish. The Village Hall Management Committee were looking at getting the car park resurfaced. They are looking at Contractors and when they have some prices they will be looking at applying for grants to meet the costs.
4. **Declarations of Pecuniary Interest:** There were none at this point
5. **Minutes**
To confirm minutes of Council meeting held on Monday 13th February 2017; it was agreed that these were a true and accurate record of the meeting: proposed by Councillor H Booth; seconded by Councillor R Davies and agreed by all members present.
6. **Matters Arising: Clerk to update on any item not on the agenda.** The clerk had received an e-mail regarding progress on the tidying up of the Sundorne roundabout. These costs would be around £5,000. It would cost £600.00 a day for traffic management when the work was being done. Shropshire Council highways are suggesting levelling it out and putting some rockery area on there which would require limited maintenance. The clerk to let those who had expressed an interest in sponsoring the roundabout know what the proposed cost would be and see how much these firms would be willing to contribute.
7. **Police Report:** This was handed out by the clerk as it had been late coming in.
8. **Local Joint Committee: LJC:** held on Thursday 23rd February 2017 at Crosshouses Community Centre. L Picton reported that at the meeting it was agreed to give money to two areas for the provision of Youth Clubs for the LJC area. These would be Berrington and Bomere Heath.
The next stage of the Broadband would be delivered to Uffington.
Shropshire Council had received some additional money for the Adult Social Care.
The Council is in purdah at the moment coming up to the Local Council Elections.
9. **Neighbourhood Watch:** The Chairman asked the clerk to chase up with Mike Jones for details of who our Neighbourhood Watch contact is. The clerk also to chase up PC D Walton who was keen to get mobile Police Stations running in the lighter nights and see when he would be doing this.
