89.23 Chairman's welcome

Councillor Padmore welcomed all to the meeting.

90.23 Apologies for Absence

None.

91.23 Disclosable Pecuniary Interests

They concluded that the proposed solar farm would have a negative impact on the area and as such Uffington Parish Council would submit an objection to the planning application due to the following material considerations:

- Detrimental effect on the landscape and visual impact
- Loss of Best and Most Versatile agricultural land
- Adverse ramifications on ecology
- Archaeological significance

- Streetlight the new streetlight outside The Corbet Arms will be installed on 24 April.

- Advert for Clerk/RFO position was prepared and placed with SALC on 26 January.

- Waste Services Consultation Shropshire Council will shortly be launching a public consultation regarding waste services which will include: green waste; permit schemes; and household recycling centres. Participation in the consultation is encouraged.

• North-West Relief Road – the conditions have now gone through and now waiting for the planning notice to be issued. Then there is a 42-day waiting period to see if a judicial review has been requested. In the meantime, borehole testing will take place.
