MINUTES OF THE PARISH COUNCIL MEETING Held at 7.30pm on 13 September 2021 in Uffington Village Hall

84.21 Chairman's Welcome

Councillor Padmore welcomed all to the meeting.

85.21 Apologies for Absence

None

86.21 Disclosable Pecuniary Interests

- a) No disclosable pecuniary interests were declared.
- b) There were no applications for a dispensation regarding disclosable pecuniary interests.

87.21 Public Participation session/Matters of Concern/Parish Matters

Mr Richard Simmons (of Canal Close) expressed concern about speeding from the turn off
to Uffington from the B5062. The speed limit on the road is 40 mph but there is insufficient
signage to this effect between the Newport Road and where the speed limit is reduced to
30 mph near the VAS. Mr Simmons believes that the speeding issue could be improved if a
couple of 40 mph speed limit signs were positioned on this stretch of road.

ACTION: Clerk to contact Shropshire Council Highways Department to see if a traffic engineer could come and inspect the signage situation.

88.21 To approve the minutes of the Parish Council Meeting held on 16 August 2021

The minutes of the previous meeting had been circulated.

resolved (without opposition)

that the minutes of the Parish Council Meeting held on 16 August 2021 be accepted as a true record.

The minutes were signed accordingly.

89.21 Matters arising from the minutes of the Parish Council Meeting of 16 August 2021

- Co-option of fifth councillor Jayne Carter now appears on the electoral roll as a resident of
 Uffington and therefore meets a criterion for becoming a parish councillor. Jayne will be coopted at October's meeting.
- Replacing Parish Council noticeboard Clerk had looked into costings of a noticeboard but needed to investigate the existing post situation further as if the legs are concreted into the ground, then the noticeboard will have to fit on to them.

ACTION: Councillor Blake to measure and photograph the noticeboard/legs and send to Clerk who can research costings of a metal noticeboard to fit on to existing poles.

90.21 To receive report from Shropshire Councillor

Councillor Picton presented a report which covered:

- Highways quite a lot of pothole issues in the area have now been fixed. Shropshire
 Council is working with a number of parish councils to see if the responsibility for
 environmental maintenance could be devolved to them.
- Pedestrianisation in Shrewsbury town centre currently stopped as Shropshire Council
 were under threat of a legal challenge from people with disabilities. Some form of
 pedestrian scheme will be reinstated at weekends towards the end of October in the lead
 up to Christmas. Publicity will be put out shortly so that people can have a say before it
 starts.
- Variable message boards in total there will be 12 digital signs installed in the town which
 as well as informing drivers how many spaces are available in the main car parks, will also
 tell motorists of delays, roadworks and incidents (such as flooding) on the road network and
 warn of congestion related to events.
- Shropshire Supports Refugees Shropshire is welcoming its first Afghan family this week.
 Donations are currently paused as so much has already generously been donated and now
 the volunteers are sorting through it all. Speakers of the following language are being
 sought to help with refugees: Pashto; Arabic; Kurdish Sorani; Farsi. If anyone knows anyone
 who speaks these languages Shropshire Council would love to hear from them.
- 2022/23 Budget being worked on. 85% of Shropshire Council's net budget is spent on 3% of the population due to the ever-increasing desperate social care situation.
- Boundary review The Boundary Commission have said that they may look at doing a Shropshire Council divisional review.

Councillor Picton left the meeting after presenting her report.

Councillor Blake confirmed that the defibrillator was ready to use as and when required.
