#### 115.21 Chairman's Welcome

Councillor Padmore welcomed all to the meeting.

#### 116.21 Apologies for Absence

Apologies were received from Councillor E Strawbridge. The reason given was accepted by the Parish Council.

#### 117.21 Co-option of Fifth Councillor

The vacancy for a fifth councillor had been advertised on the Parish Council's website and noticeboard over the summer. One application was received, from Ms Jayne Carter.

It was proposed by Councillor Padmore and seconded by Councillor Daimond and

#### resolved (without opposition)

that Ms Jayne Carter be co-opted as a Parish Councillor. Ms Carter then signed the Declaration of Acceptance of Office, witnessed by the Clerk.

#### 118.21 Disclosable Pecuniary Interests

- a) No disclosable pecuniary interests were declared.
- b) There were no applications for a dispensation regarding disclosable pecuniary interests.

#### 119.21 Public Participation Session

No members of the public present.

#### 120.21 To approve the minutes of the Parish Council Meeting held on 11 October 2021

The minutes of the previous meeting had been circulated.

It was proposed by Councillor Blake and seconded by Councillor Daimond and resolved (without opposition)

that the minutes of the Parish Council Meeting held on 11 October 2021 be accepted as a true record.

The minutes were signed accordingly.

#### 121.21 Matters arising from the minutes of the Parish Council Meeting of 11 October 2021

• Clerk had spoken with Traffic Engineer (David Gradwell) at Shropshire Council about getting 40 mph speed roundels on the road between the turn off from the Newport Road and the VAS, advising that the Parish Council would fund this if necessary. Mr Gradwell said that someone would inspect the area at some point and any work considered appropriate by Shropshire Council would be carried out before the end of the financial year at no cost to Uffington Parish Council.

## 122.21 To receive report from Shropshire Councillor and/or Safer Neighbourhood Team (West Mercia Police)

Nobody from the SNT was able to attend.

Councillor Picton presented a report which covered:

- Bus Transport Shropshire Council have submitted a bid of £98 million to the Department
  for Transport as part of the Bus Back Better scheme to transform bus transport across the
  whole of the county. Green buses, Sunday services, real time passenger information and
  more affordable fares all part of the programme. The Council wants to deliver a service
  which makes bus travel a real option for people across Shropshire especially in rural areas.
  Earlier this year an online consultation took place asking for the public's thoughts on bus
  services as they are now and what improvements they would like to see. More than 2,500
  responses were received. The bid also includes a redesign of the current Shrewsbury Park &
  Ride service
- Boundary Review the Boundary Commission for England is no longer going to be carrying out a town and parish council review but will be conducting a divisional review instead.
- Budget the government's recent budget did nothing to help Shropshire Council so there remains a blackhole of around £17M.

Councillor Picton left the meeting after presenting her report.

#### 123.21 To receive the defibrillator report for the period

Councillor Blake confirmed that the defibrillator was ready to use as and when required.
