

Monday 10th June 2019

MINUTES

1. **Chairman's Welcome** the Chairman welcomed all to the meeting.
2. **Declarations of Pecuniary Interest;** there were none at this point
3. **Present** Councillor L Padmore-Chairman, Councillor P Daimond-Vice-Chairman, Councillor A Blake, Councillor R Davies, Councillor E Strawbridge. Also present were Shropshire Councillor L Picton, L Pardoe clerk to the Council Jason Jordan from Sundorne Estates & Apologies were received from Mrs B Ashton , Ffion Horton from Shropshire Council who was in hospital and unable to attend.
4. **Ffion Horton from Shropshire Council to speak to members about the Sundorne Roundabout and traffic calming measures through the village.** Ffion was not present and members were again frustrated at the lack of any further development in the tidying up of the Sundorne roundabout. The Chairman reported that she had received a telephone call from a lady in the village who had had a near miss from a speeding vehicle on the roundabout. The chairman asked the clerk how many e-mails she had sent to Steve Brown at Shropshire Council this month asking for updates. The clerk replied 2, or 3, the chairman asked the clerk to forward these e-mails to herself so she could show them to the lady in questions husband. The clerk was concerned at giving out this information to a member of the public but was instructed to send them to the chairman. Councillor L Picton suggested that the clerk write to the Head of Shropshire Council, Peter Nutting and see if he was able to assist moving the matter forward. The clerk explained that she had written to Steve Brown asking that, even though no decision on what to do regarding the roundabout had been made, could they please at least cut it when they cut the other roundabouts on the outskirts of Shrewsbury. She had not yet received a response to this e-mail. Councillor Picton explained that part of the problem at the moment was that the new contractors were not actually doing anything.
5. **Public Session.** Jason explained that the Police had dealt with their fly tipping issues. Although in the 7 days after this there had been 8 further incidents. He had had a couple of near misses with people parking on the grass in front of his house making exiting dangerous. Council members stated that Shropshire Council Highways cut the grass that the cars are parked on. Jason said he believed the grass was a visibility splay for his property. The clerk would look at if this was a Parking enforcement issue if the cars were obstructing the exiting of the property.
6. **Police Report:** There was no report at the time of the meeting although the clerk received one the following day which she forwarded to members.
7. **Council to agree minutes of meeting held on 13th May 2019.** It was agreed that these were a true and accurate record of the meeting. Proposed by Councillor R Davies, seconded by Councillor A Blake and agreed by all members.
8. **Clerk** reported that she had applied for the grant for Smart water from the PCC and had received an invoice from Smart water and terms and conditions of the grant .The Chairman wanted to know why the clerk still did not have a new register of Electors, the clerk explained that she had been told that she would not be able to have one until the European Elections were completed. The Chairman took the copy of the electoral role that the clerk had. It was explained that the Chairman wanted to mark off every household on the list when they receive the free Smart water packs on Roll Out day on 22nd June. Clerk to get an up to date Register from Elections.
9. **To receive Reports from Shropshire** Councillor L Picton reported that the proposed transport savings had been shelved for the time being. However the charges for the Park & Ride are to go up to £2 and family tickets will now replace the group ticket. The pensioner's concession will be £1.
It is important for the parishes to ensure that their Place Plan priorities are up to date. She also explained that the clerk should complete an Expression of Interest application for the Traffic Scheme which had been drawn up for Uffington, to see if we are able to move this matter forward in this way. Clerk to send details of the scheme to Councillor Picton for her information.
