29.23 Chairman's welcome

Councillor Padmore welcomed all to the meeting, especially the new councillors Claire Ashton and Sophie Poole.

• Notified Electoral Services at Shropshire Council of the co-option of two councillors.

35.23 To receive report from Shropshire Councillor

Councillor Picton said she did not have a huge amount to report but touched on:

- Boundary Review Shropshire Council's submission in response to The Local Government Boundary Commission for England's Shropshire Review has now been signed off. No changes made to what LGBCE had proposed for Uffington: Coracle Close and Pimley Manor will leave the parish of Uffington and move into the Sundorne Ward under Shrewsbury Town Council. Finalised changes will come into effect in May 2025 after the next elections.
- The North-West Relief Road hopefully going to Planning in early September.
- Shropshire Council's Financial Position despite what the Labour Leader says, Shropshire Council is not going bankrupt. In a similar position to other councils throughout the country in having to make large savings (£51M) but this includes putting money back into the reserves. This is being tackled and by the end of the year should be on a firm financial footing. Councils are under huge financial pressure and it is all down to social care.
- The Local Plan does not impact on Uffington as the parish is classified as Open Countryside.

Councillor Picton left the meeting after the conclusion of her report.

36.23 To receive defibrillator report for the period

As mentioned in Clerk's Report, MedUK will now carry out a health check on the defibrillator on a monthly basis and will advise the Clerk of outcome to record on The Circuit. MedUK have confirmed that the AED is currently ready for use as and when required. A software update to the equipment has been identified as necessary and MedUK will be taking it away imminently to facilitate this. A replacement loan will be provided while our AED is temporarily away.
