# MINUTES OF THE PARISH COUNCIL MEETING Held at 7.30pm on 11 July 2022 in Uffington Village Hall

#### 44.22 Chairman's Welcome

Councillor Padmore welcomed all to the meeting.

# 45.22 Apologies for Absence

Apologies were received from Councillor A Blake.

### 46.22 Disclosable Pecuniary Interests

- a) No disclosable pecuniary interests were declared.
- b) There were no applications for a dispensation regarding disclosable pecuniary interests.

### 47.22 Public Participation

Councillor Picton excused herself from the meeting for the duration of the presentation and all subsequent discussion relating to the proposed solar farm.

As part of their community involvement process, Alexander Miejimolle and Guillermo Fernández Gil of Opdenergy gave a presentation on the proposed solar farm development on land west of Haughmond Quarry. The presentation document can be viewed on the Parish Council website under the heading <a href="Proposed Solar Farm">Proposed Solar Farm</a> and further information is available at <a href="https://www.uffingtonsolarfarm.co.uk">www.uffingtonsolarfarm.co.uk</a> The presentation lasted 15 minutes, after which a 45-minute Q&A session followed.

Opdenergy have sent out questionnaires to 480 households in the area requesting that they are completed and returned by 27 July 2022. To date, 26 questionnaires have been returned (17 in agreement, 2 neutral and 7 disagreeing with the proposal). The solar farm planning application is likely to be submitted late August/early September 2022. It is hoped that a community meeting can be arranged to coincide with this when further questions and concerns could be addressed.

The Chair thanked Messrs Miejimolle and Fernández Gil for their time and insight. Together with 8 members of the public, they then left the meeting. Councillor Picton rejoined the meeting.

# 49.22 Clerk's Report on matters arising from the minutes of the Parish Council Meeting of 9 May 2022.

- Submitted AGAR to external auditors PKF Littlejohn before stated deadline.
- Published annual accounts for 2021/22 to website together with Notice of Public Rights to view any records between 13 June to 22 July.
- E.ON have supplied a quote to replace the street light on Church Road. The quote is £1259.14

# 50.22 To receive report from Shropshire Councillor and/or Safer Neighbourhood Team (West Mercia Police)

Nobody from the SNT was able to attend.

Councillor Picton reported that:

- From 1 July the Clinical Commissioning Groups (CCGs) have been replaced by the Integrated Care Systems (ICSs). ICSs are partnerships of organisations that come together to plan and deliver joined up health and care services, and to improve the lives of people who live and work in their area. NHS Shropshire, Telford and Wrekin (NHS STW) and the two unitary councils (Shropshire Council and Telford & Wrekin Council) jointly form a statutory committee called the Integrated Care Partnership (ICP). The ICP will bring together a broad alliance of partners involved in the delivery of health and care services. Councillor Picton is the Joint Chair of the ICP.
- Telford and Wrekin Council commissioned an independent investigation into Child Sexual Exploitation in Telford, the findings of which are being released tomorrow (12 July) at 5pm. Shropshire Council will need to issue a statement in response because the inquiry investigated historical crimes and between 1989 and 1998 (a period covered in the inquiry), children's social care in Telford was the responsibility of Shropshire County Council.
- Children's Services received a "good" OFSTED rating despite being under huge pressure.
- The preliminary census results have been released and unsurprisingly we are all getting older in Shropshire and older people are now far outnumbering younger people.
- The Draft Local Plan Public Examination began last week at Shrewsbury Town Football Club but the second week is having to be held virtually as a number of people attending have come down with Covid.

Councillor Picton left the meeting after delivering her report.
