- 1. Chairman's Welcome: The Chairman welcomed all to the meeting
- 2. Declarations of Pecuniary Interest; There were none at this point
- 3. Present: Councillor L Padmore Chairman; Councillor R Davies; Councillor P Daimond, Shropshire Councillor L Picton, L Pardoe clerk to the council; **Apologies** were received from Councillor A Blake work commitments and Councillor R Simmonds who was unwell. Apologies were also received from Mathew Mead from Shropshire Council.
- **4. Public Session:** There were none present.
- 5. Police Report: The clerk had not yet received a report for the Police for the month of December and would circulate it to members when it was received. The clerk reported that she had received a response from PC D Walton re the dangerous dogs reported last month and also in November. He had visited the person concerned and they had told him that they were now walking the dogs in a different area. He has also said that his dogs had been approached by other dogs who were off their leads. Councillor Davies was not happy with this reply and wanted to follow this up with the Policeman as he was concerned that the dogs might attack a small child in a similar situation. The clerk to invite PC Walton to attend the next Parish Council meeting.
- 6. Clerk had nothing to report all matters were covered on the agenda.
- 7. To receive Shropshire Councillor's Report Councillor L Picton reported that she was unable to give us any further information on the Battlefield roundabout and suggested trying a different track. She suggested that the clerk contact Rea Valley Tractors direct and ask how much they would be willing to contribute to the refurbishment of the roundabout. Councillor Picton would then take this response to Chris Edwards asking for support for the project. The whole village now has superfast broad band but Councillor Daimond said that hers had not been working and Open reach were having to dig up the road around the junction box and replacing it as the wires etc were a mess. This was scheduled to be done on 12th January 2018.
- 8. **Council to discuss Shropshire Council consultations** .There are no new ones out at present.
- 9. Council to adopt protocol on Councillor /Clerk Relations. It was agreed to adopt this protocol. Proposed by Councillor L Padmore and seconded by Councillor P Daimond and agreed by all members present. The Chairman signed the document for the council records.

10. To receive reports from

- LJC Shropshire Councillor L Picton reported that this time in the Local Plan there
 would be no change for Uffington's status. Shropshire Council will say which parishes
 are to be Hubs. The Council agreed to wait to see what sites are identified and then
 look at if they want to ask for their status to be changed From a Hub to Open
 Countryside. The list of sites would be put in the Parish Magazine.
- Neighbourhood watch; there was nothing to report.
- Any other meetings attended by members; the clerk had attended a briefing in November on the new Data Protection Regulations which were due to come into force on 25th May 2018. The Parish Council had to appoint a Data Protection Officer. This person had to satisfy certain demands to be the DPO. The clerk had received some information and had three options for the Council to consider. After discussion the parish council agreed to appoint Mr Malley subject to sight of his qualifications and public liability insurance. Proposed Councillor L Padmore seconded by Councillor P Daimond and agreed by all members present.
